Elementary School Mental Health Program
2010-2011

Background

In early 2010 Marla Stephenson, the Superintendent of the Albany Unified School District, and Joanne Wile, LCSW, began a series of meetings to evaluate mental health resources at the Albany elementary schools. We met with the Director of Berkeley Mental Health, Berkeley and Albany school clinicians, and the Albany representative to the Berkeley-Albany Mental Health Commission.

Following these meetings, in consultation with the school district's Mental Health Committee, we decided to continue Berkeley's counseling services, through interns, at Ocean View School and hire Joanne Wile, LCSW for a five hour/week position to develop an internship program with volunteer faculty supervisors at Cornell and Marin Schools. The plan was to capitalize on her professional connections with the UC School of Social Welfare faculty and her work in the psychotherapy community in the East Bay.

Start-Up

Four first year interns from the School of Social Welfare provided counseling and group services at Cornell and Marin Schools. A psychology intern was placed at Ocean View with a supervisor from Berkeley Mental Health. Four supervisors were recruited from the Berkeley and Albany communities to serve as volunteer faculty, in addition to Joanne Wile, who served as group supervisor and individual supervisor for the Management and Planning social work intern.

The interns started in late October, 2010 and ended April 29, 2011. With weekly seminars, individual, and group supervision they had approximately one and a half days each week to provide services and observe the children in classrooms and on the playground. Interns received referrals through each principal and met with teachers and families. Reasons for referrals ranged from symptoms of anxiety, depression, social isolation, aggression, and hyperactivity.

We began the program with no resources other than the energy and commitment of all the clinicians. We had no office space, computers, telephones, play therapy space, or equipment. We received donations of toys, computers, and printers. The principals set aside play therapy, group, and office space at the two schools. After a month's preparation, the interns began individual and group sessions in the newly designed rooms.

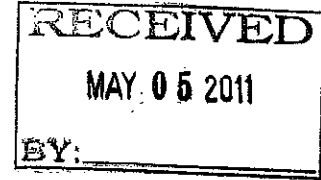

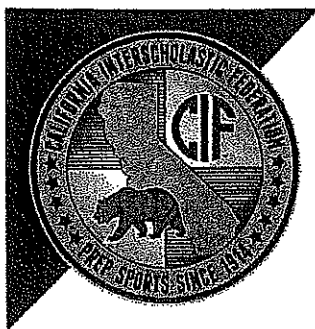

Enclosed is a form upon which to record your district and/or school representatives to leagues for next year **2011-2012**. It is a form sent every year to you in order to obtain the names of league representatives to every league in the state and to make sure that the league representatives are designated by school district or school governing boards. **It is a legal requirement that league representatives be so designated.**

The education code gives the authority for high school athletics to high school governing boards. The code also requires that the boards, after joining CIF, designate their representatives to CIF leagues. This is a necessity! (Ed. Code 33353 (a) (1))

We are asking that, after action by the governing board, you **send the names of league representatives to your CIF Section office**. Obviously, the presumption behind this code section is that the representatives of boards are the only people who will be voting on issues, at the league and section level, that impact athletics.

If a governing board does not take appropriate action to designate representatives or this information is not given to Section offices within the required time frame, CIF is required to suspend voting privileges (CIF Constitution, Article 2, Section 25, p.16) for the affected schools.

At the State Federated Council level we will be asking that Sections verify that their representatives are designated in compliance with this Ed. Code section.

I hope this gives you a bit of background. Thank you for all you do to help support high school athletics. It is a valuable program in all high schools and we appreciate the support you give to the program and to CIF.

Please return the enclosed form no later than July 1, 2011 directly to your CIF Section Office. Addresses of each section are listed on the back of the form. Please contact us if we can give you further information.
